Envelopes should be marked as **"Bids for Valuation Work"**. **Bidder's name, address and contact details, should also be marked on the envelope.**
- 5) **Bidder must be a registered valuer for work (land, building, plant & machinery given in the bid document. Copy of registration to be enclosed with Bid.**
- 6) Only ONE Bid will be accepted from ONE firm/ party. There should not be any over writing/cutting in the Bid. No bid will be accepted for part work.
- 7) Valuation report should be completed & submitted for Gangapur city project within 10 days and for other 04 projects within 45 days from the date of receipt of work order. Valuation report can be submitted projectwise in priority as given in the table above.
